NYSDOH Update - Medical Records Abstractions

We have received a notice from the NYSDOH letting us know that the DSRIP Independent Assessor has partnered with two HEDIS-certified medical record review abstraction firms (MedReview, Inc. and Verisk Health, Inc.) to complete chart abstractions for all PPSs statewide. The NYSDOH has indicated that an initial chart abstraction will involve data for DSRIP measurement year 1 (7/1/2014 - 6/30/2015) which will establish baseline measures that will be used to set performance improvement targets. Six HEDIS measures and two State-developed non-HEDIS measures (screening for clinical depression and viral load suppression) will be included in the collection effort.

The NYSDOH timeframe for the completion of the initial chart abstraction process runs from September 1 through November 27, 2015. MedReview and Verisk Health are subject to HIPAA and their work will be monitored by the NYSDOH. If you are contacted by either firm, we ask that you please comply as required with their request for information. Please also let us know if you are contacted and/or if you have any questions or concerns at this time (support@CCBrooklyn.org).

We will be participating in an informational webinar for PPS leads on September 10th to learn more about the chart review process. We will provide an update at the PAC meeting that afternoon and will include additional information in a subsequent CCB newsletter.

Other Updates

Capital Restructuring Financing Program (CRFP) Application Submission Completed

The window for resubmission of CRFP applications to the NYSDOH closed on September 1st. CCB submitted four revised and three new applications, along with a cover letter reiterating the importance of all 68 CRFP applications filed on behalf of CCB Participants and stressing the critical need for capital funds to ensure the achievement of key DSRIP goals in Brooklyn.

With the most recent submissions, CCB's request for CRFP capital funds totals to more than \$311 million for projects with \$88 million in matching funds committed. We will follow up with additional information as it becomes available.
